2009-2010	During the time that Sandler was acting for the crown managing the case against Bryant he was also working on a big case with David Porter. The case was R v De Zen et al 2010 ONCJ630 and they won it on December 10 2010 after a 5 month trial. The trial would have started in late June or early July which is about one month after Peck and Sandler dropped the charges against Bryant. It's safe to say that Porter and Sandler spent more than a couple months preparing for a five month trial which means that they were working together at the same time Sandler was supposed to be acting as a prosecutor and managing Bryant's case.	2009-2010	In 28 Seconds on page 178, Bryant wrote: "Near the end of that first week David Porter was instrumental in taking me through all the factors at play in my case. He pulled over to the side of the road and gave me close to an hour on the phone, and had clearly put his mind to it in advance."
